

# RESULTS OF VOTING (EVOTING & POLL) IN RESPECT OF THE RESOLUTIONS PASSED AT THE 92<sup>ND</sup> ANNUAL GENERAL MEETING OF THE EQUITY SHAREHOLDERS OF GAMMON INDIA LIMITED HELD ON 30<sup>TH</sup> JUNE 2014.

As per the provisions of the Companies (Management and Administration) Rules, 2014 and Clause 35B of the Listing Agreement, the Company had provided e-voting facility to all the members holding shares of the Company as on the cut-off date i.e. 23<sup>rd</sup> June 2014 to enable them to cast their votes in respect of the resolutions as set out in the Notice of the 92<sup>nd</sup> Annual General Meeting ("AGM") of the members of Gammon India Limited (the "Company"). The e-voting period opened at 9.30 a.m. on Tuesday, 24<sup>th</sup> June, 2014 and concluded at 5.30 p.m. on Thursday, 26<sup>th</sup> June 2014. Mr. Vidyadhar Chakradeo, Practising Company Secretary, who was appointed as the Scrutinizer for independently carrying out the electronic voting in a fair and transparent manner submitted his report on e-voting.

In the  $92^{nd}$  AGM of the members held on Monday,  $30^{th}$  June 2014, I presided as the Chairman of the meeting. To facilitate all those members present at the AGM either personally or by proxy and who had not cast their vote earlier, but who would like to vote at the AGM, I ordered a poll in respect of all items of business from 1 to 15 as set out in the Notice of the  $92^{nd}$  AGM. Mr. Vidyadhar Chakradeo of M/s V. V. Chakradeo & Co. was appointed a Scrutinizer for conducting the poll.
